The School of Accountancy's long awaited interview workshop has come and gone, and by all appearances it was a smashing success. The workshop was a chance for 60 accounting students to prepare for their day at the career fair.

SOA Director, Dr. Stephanie Bryant, gave a brief but impassioned presentation on what NOT to do at the career fair: chewing gum, texting, wearing casual clothing, having a resume full of typos. She emphasized that students would have only about 5 minutes to impress a recruiter and warned, "you are being judged on how you present."

But the mood lightened somewhat with the hilarious yet informative presentation from Protiviti's Ali Hall and Met-Life's Jason Pandolfo and Ryan Ratigan. Besides warning students about the dangers of wearing bike helmets and dancing drunkenly at the career fair, their presentation advised students to let their personalities shine through and to demonstrate personal responsibility and passion. They also suggested preparing a few specific anecdotes of a time when the student solved a problem or demonstrated leadership.

After the presentations, a professional worked with groups of students at each table to help students answer some common interview questions. Our group first spoke with Bob Watts of Resources Global, an accounting consulting firm. As he started asking questions, it was obvious that students underestimated how nervous they would be in this situation. However, Bob did a great job at making students feel at ease, and soon there was a strong sense of camaraderie. This turned out to be the best and most valuable part of the event. It's much better to get nervous at the mock interview than the real thing, so students who attended will be that much better prepared for the career fair.

Later, the groups of students rotated to other tables. My next group spoke with Aaron Lamb of Kforce, a recruiting and HR consulting firm. He was energetic and very knowledgeable about interview techniques, and he helped us answer the trickiest interview question of all, "What's your biggest flaw?" ("I work too hard." won't work.) He also gave us general networking and job-seeking advice and gave out his card, saying he'd be available any time to help with the search.

When asked how she would sum up the event, Dr. Bryant simply said "60 students getting together with 15 professionals—a fabulous event." The students who attended are likely to agree.

While meeting with the member of BAP St. Pete, we were able to learn much about their organization including member and candidate requirements and how they interact with firms in the community.



He taught Auditing and Accounting Information Systems for 10 years before transferring to the St. Pete campus.

With a bachelors degree in Economics, and a masters and Ph.D. in Accounting, Dr. Lander has a remarkable record. He has been published more than 16 times, with publications that explore the need for transparency in financial reporting, the valuation of intangible assets, variable-interest entities, among many others. Throughout his career at USF, Dr. Lander has also taught a total of seven courses in the Accounting department.

Dr. Lander also received the *Out*standing Teacher Award in 2004 from the College of Business, evidence to his commitment to our university. In addition to his academic achievements, he also spent time working in management and public accounting prior to teaching. He also has Big 4 experience, having worked at Deloitte. Dr. Ryan Huston comes to USF's School of Accountancy with a wealth of teaching and professional experience. He currently teaches Taxation of Business Entities and Advance Partnership Taxation.

Prior to arriving at USF, Dr. Huston was an Assistant Professor at Florida State University where he taught Estate and Gift Taxation and Partnership Taxation. While at FSU, Dr. Huston was awarded the Graduate Teaching Award for 2009-2010. Prior to FSU, he was an instructor at Texas A&M University where he taught Introduction to Taxation. Dr. Huston also worked in public accounting for KPMG and Arthur Andersen in Dallas before beginning his career in academia.

Dr. Huston holds a B.B.A., M.S. and Ph.D. in Accounting—all from Texas A&M University. His current research interests include archival empirical taxation and the associated impact on financial accounting and earnings management. His current publications under review include topics such as earnings targets, tax incentives, income taxes, tax planning and worldwide vs. territorial tax systems.

He has presented numerous times for the American Taxation Association on multiple areas of taxation, investment and earnings management. Additionally, Dr. Huston has been invited to present at some of the leading universities around the country including Baylor Uni-



versity, Auburn University, Georgia Institute of Technology, University of Notre Dame, Arizona State University and a host of others.
